

Our postgraduate courses are listed by subject area on the following pages. Many of our MA and MSc programmes can be studied as a Postgraduate Certificate or Diploma.

The difference between Postgraduate Certificate, Diploma and an MA or MSc is in the amount of credits the course contains. An MA or MSc contains 180 credits – 120 credits of taught units and 60 credits for a dissertation.

If you successfully complete half of the taught units (60 credits), you are awarded a Postgraduate Certificate. If you successfully complete all of the taught units (120 credits), you are awarded a Postgraduate Diploma.

If you complete the taught units (120 credits) successfully you can then write a dissertation or research project (another 60 credits) and are awarded a MA and MSc. A fee is listed for each course entry. These fees are correct at the time of going to press and are subject to change. For up-to-date fee information, please visit mmu.ac.uk/courses

## Community Health PgDip

#### Length and Mode 1 year full-time

2-3 years part-time. (Attendance is one day in practice and half a day study per week).

Fees Full-time UK and EU students: £12,500\* Part-time UK and EU students: £695 per 10 credit unit. (A Masters qualification typically comprises 180 credits). Full-time non-EU overseas students: £12,500

#### **Entry requirements**

You will normally have a first degree (minimum 2:2) in a relevant subject, and demonstrate the ability to study independently at level 7. You must also have completed a period of experience of sufficient length to have consolidated pre-registration outcomes and have gained a deeper understanding in relevant professional practice. You must be supported in practice for the duration of the course by an appropriately qualified Sign-off Mentor or Practice Teacher. You must also meet the specific entry requirements for the Specialist Practitioner Qualification (SPQ).

For Community Children's Nursing applicants must be registered as a first level nurse – children (RN8, RNC).

For Community Learning Disabilities applicants must be registered as a first level nurse – learning disabilities (RN5, RNLD). For District Nursing applicants must be registered as a first level nurse – adult (RN1, RNA).

For General Practice Nursing applicants must be registered as a first level nurse – adult (RN1, RNA) or a first level nurse – children (RN8, RNC). International students please visit mmu.ac.uk/international or see page 30.

#### The course

The course is approved by the NMC to offer students the opportunity to gain a specialist practitioner qualification in Community Children's Nursing, Community Learning Disabilities Nursing, District Nursing or General Practice Nursing.

Other units studied depend on the specialist pathway chosen.

#### **Assessment**

Assessment strategies are devised to equip students with skills that can be used in their professional development and clinical practice (eg writing reports and journal articles, giving presentations, developing portfolios).

#### Career prospects

All successful graduates will be eligible to apply for a Specialist Practitioner role in the specific field of practice.

### Specialist Community Public Health Nursing (Health Visiting or School Nursing) PgDip

Length and Mode 2-3 years (top-up degree with advanced entry)

Fees Course fees are paid for by the NHS. In addition, some students may receive an NHS dependent on eligibility. Please visit www.nhsbsa.nhs.uk/students for information. Entry routes: via the Health Visiting studentship with secondment funding – (course fees are paid and the NHS North of England will pay a salary whilst you study) or by direct application – (course fees are paid with a bursary available as study support).

#### **Entry requirements**

Applicants must be a first level nurse or midwife with a current or pending registration on the NMC Professional register and must have a supported practice placement. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This course is designed to lead to careers in Health Visiting or School Nursing. There is a focus on public health, community development, health needs assessment and health inequalities. All aspects of the course focus on the development of skills, knowledge and attributes required for the SCPHN role. The course leads to registration on part three of the NMC register for Specialist Community Public Health Nursing.

#### **Assessment**

This course is 50% theory, 50% practice (NMC requirements). Placements are secured by the employing Trust ensuring a practice teacher supports you in practice throughout the course. Assessment is through written assignments, presentations, examinations and assessment of practice.

#### Career prospects

All successful graduates will be eligible to apply for a Specialist Practitioner role in their specific field of practice (Health Visiting or School Visiting).

## Emergency Medicine PgCert/PgDip/MSc

Length and Mode Up to 6 years part-time, distance learning. Fees Part-time UK, EU and Non-EU overseas students: £745 per 20 credit unit.

(A Masters qualification typically comprises 180 credits.)

#### **Entry requirements**

Applicants must be a registered nurse or medical practitioner (depending on the route chosen) who is practising or has recently practised in an area of urgent or emergency care. You may also be required to take part in a telephone interview. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This course offers professional education and an academic qualification for nurses and physicians in emergency contexts. Four distinct study routes are available and all have been designed entirely by physicians and nurses experienced in emergency care. Teaching is online and based around a virtual hospital with problem-based learning, online lectures, tutorials, web links and online discussions with colleagues and fellow students. The course is made up of two phases: phase one provides a range of core and elective units from which you can select your personalised route; phase two consists of a substantial practitioner project in a field of emergency medicine of your choice

#### **Entry requirements**

Entry to the programme requires you to be a registered medical practitioner who is practising, or has recently practised in an area of urgent or emergency care. Your application will also be subject to a successful interview, usually by telephone. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This flexible, modular programme is designed to meet the needs of a range of Health Care Professionals. With entry points throughout the year we deliver a diverse selection of multi-professional units that includes: research, mentorship and leadership – as well as units specific to subjects such as nursing, medicine and public health. Once successfully completed, units can be 'banked' for a future Accreditation of Prior Certified Learning (APCL) contribution to other degree courses – undergraduate or postgraduate – as appropriate. Assessment is through a combination of essays, presentations, portfolio work or clinical skills development.

#### Career prospects

The modular programme provides a flexible, accessible learning opportunity to fulfil personal or professional needs and interests. Additionally, it can enable access to other degree courses.



## **Case study**Dr Abebaw Yohannes

#### Lecturer in Physiotherapy

As well as being a lecturer in Physiotherapy at the University, I am also involved in my own research. I specialise in respiratory diseases, especially in older patients with chronic obstructive pulmonary diseases (COPD), and explore the design scale for anxiety symptoms in patients with COPD. I also conduct research into mental health in older people.

Here at Manchester Metropolitan University we boast amazing research facilities. For example, we have equipment for measuring lung function and exercise capacity as well as other specialist equipment. The staff at the University are experts in their fields, and are especially renowned within the field of respiratory disease.

Studying in this area can develop your career in many ways. You could go on to conduct research, though many students go on to work as clinicians in respiratory diseases. COPD is one of the government's key agenda points and the focus on the promotion of public health initiatives in detection as well as treatment makes it a key growth area.

#### **Entry requirements**

An undergraduate physiotherapy honours degree or graduate diploma in physiotherapy – with evidence of approved and relevant post-qualification education is usual. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This advanced study programme provides practising physiotherapists with the opportunity to study for a specialised postgraduate qualification – which will significantly contribute towards career development. It aims to provide clinicians with the ability to evaluate current professional practice by promoting systematic enquiry and the development of the individual's research skills.

Other aims include developing and broadening the clinical status and knowledge base of physiotherapists to enable them to be more effective contributors to their particular field of healthcare. In addition to studying a range of selected units, you will normally undertake four optional units – the combination of your units will be dependant on your route.

#### Assessment

With flexibility being key to this programme, there is scope for individual time plans for course completion. Most modules can be undertaken as stand-alone continuing professional development (CPD).

#### **Career prospects**

A postgraduate qualification in physiotherapy aims to enhance your career as a clinical specialist in your chosen field of practice. For those considering teaching as a career option, it is an expected qualification. The Faculty of Health, Psychology and Social Care's Professional Doctorate (Health) award might also be of interest.

## Physiotherapy (Pre-Registration)

#### **MSc**

Length and Mode Full-time 2 extended years (45 weeks) – January start date only

Fees A number of places are funded by the National Health Service. Tuition fees for UK/EU students are fully funded. Students who are offered bursary places do not need to apply for bursary funding as the department does this automatically once the offer of a bursary place has been accepted. Students who are personally eligible and are accepted for an NHS funded place may receive an HNS Bursary. (Please visit www.hnsbsa.hns.uk/students for more information).

#### **Entry requirements**

An undergraduate physiotherapy honours degree or graduate diploma in physiotherapy – with evidence of approved and relevant post-qualification education is usual. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This is an accelerated programme that provides an opportunity for graduates to gain the knowledge and skills to practise as a physiotherapist. Successful graduates of this MSc are eligible to apply for membership of the Chartered Society of Physiotherapy and for registration with the Health Professions Council (HPC). With tutorial teaching as key, the programme content aims to develop a student's ability to integrate theory with practice and to demonstrate a high level of critical thinking. There is also a strong focus on placements.

#### Assessment

Assessment is through a mix of coursework, written and practical examinations, practice placements, reflective writing, case reviews, oral presentations and a research proposal.

#### **Career prospects**

There are opportunities for work within the NHS, in the private sector or overseas. Most graduates start their work in the NHS which is recommended; qualified physiotherapists can work in a wide range of settings, including hospitals, health centres, private practice, sport and industry. With the development of rehabilitation teams in intermediate care and in the community, physiotherapy is well-placed in terms of career potential. There are also opportunities for postgraduate study and research.

#### The course

This course is suitable for a range of healthcare practitioners. This is designed to enable healthcare practitioners to develop practice in their own area of expertise. It will equip you with skills in: change management, evaluation and analysis of practice and the practice environment and project management. There are 10 routes through the course: emergency care; nursing practice; community practice; substance use and misuse; health protection; ophthalmic practice; managing practice; public health; community matron; and research in practice. A generic route is also offered.

In phase 1 of the course 3 core units will be typically taken – plus 3 other units dependent on the route taken. Phase 2 units vary depending on the route taken – as shown below. Most routes also have an elective unit option. Choose your own route through the programme, taking any units you wish, allowing for the study of three core units. Alternatively, choose a modular approach, undertaking single units only.



#### The course

#### **Taught Route**

The taught psychology route is one of the most flexible on our continuing professional programme offering a diverse portfolio of modules. You may choose modules from our clinical communications, community, critical, counselling, disability studies and forensic routes, as well as core research modules of personal and professional development, preparing for academic practice, quantitative research methods, qualitative research methods, and dissertation. The route is most suited to those wishing to undertake higher level general studies in psychology, or for those who want to develop their professional understanding and skills in specific areas of psychology. It is also possible to design a specialised programme that is not available via one of the main routes.

#### **Research Route**

The research route is most suitable for those who wish to undertake a higher research degree, but do not wish to commit to an MPhil or PhD at this point. It enables you to undertake a substantial dissertation in any area of Psychology, supported by taught units — usually in research methods and/or a specialist subject.

Students opting for both routes benefit from an ongoing research environment, as well as access to the activities of the Research Institute of Health and Social Change (RIHSC). Academic supervisors are research active and contribute to RIHSC.

#### Assessment

For both routes, assessment is undertaken continuously.

#### **Career prospects**

Successful completion of this course may equip you with the skills to pursue research posts or gain promotion in the workplace.

## Psychology and Counselling PgCert/PgDip/MSc

#### **Entry requirements**

You will normally have an undergraduate honours degree (second class or above), or a postgraduate diploma, or degree-equivalent professional qualification. You will also hold a GCSE or equivalent in English language and have 50 hours of formal or informal relevant experience. Exceptionally you may be admitted if you have an unclassified degree with evidence of ability to work to second class honours standard and significant professional work experience. MSc entry requires successful completion of a PgDip or equivalent. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This route offers you the opportunity to critically explore and develop your understanding of the psychological foundations of therapeutic processes.

Alongside the Dissertation unit and the Personal and Professional Development unit, the Psychology and Counselling route requires you to take three other mandatory core units: Counselling and Psychotherapy, Counselling in Context and Psychological Explorations of Counselling Interactions. Students will also be required to undertake a further 40 credits of study.

In each core module, learning takes place through a combination of lectures, group presentations and discussions, as well as participative workshops. Through these units you will explore the key theoretical counselling models and techniques, including their historical development, their philosophical underpinning and current practice issues. You will also learn about the contextualised nature of the counselling process and learn to identify the cultural, social and economic forces which impact on theory, research and practice in this area of applied psychology.

This programme may be suited to those already in practice wishing to return to academic study, as well as those who intend training at a later date to be practitioners.

#### Assessment

This modular-based programme is assessed through a process of continuous assessment.

#### Career prospects

UK Graduates from this route have taken up research posts, returned to their counselling and lecturing posts or moved onto further courses to train as Counsellors, Psychotherapists and Practitioner Psychologists. Some overseas graduates from this route have returned to their home country to take up practitioner posts. Please note this is not an accredited course and completion does not offer a licence to practice in the UK.

#### The course

This programme is specifically designed to meet the criteria of the British Psychological Society (BPS) Division of Forensic Psychology Training Committee. It is accredited as the first stage towards becoming a Chartered Forensic Psychologist. This programme is only open to applicants who possess the BPS Graduate Basis for Registration/Chartering or its equivalent as recognised by the BPS Admissions Committee.

#### **Career prospects**

Many successful graduates have found positions as clinical psychologists or psychologists in prisons and secure units or the probationary service. One has set up the first victim support unit in her local community.

Depending on the programme studied, there are also opportunities to pursue professional qualifications in higher level research and study, such as MPhil and PhD.

#### The course

These programmes are the first in the UK in Community Psychology and provide a unique opportunity to develop psychological understanding and social facilitation skills through working with people in the community.

The taught programme is best suited to those who may be relatively new to working with local people for change towards a more just society, or new to psychological frameworks. You will explore the key principles of working in the community psychologically and to develop skills of participative enquiry and evaluation.

#### Units

The research programme is best suited to those who have already done a substantial amount of work with community organisations. The course will be ideal for professional development purposes and you will be able to carry out your assignments and research in your own workplace if you wish.

For students following the research or part-time route, assignments and research can be carried out in your own workplace as wished. You will be assessed continuously throughout the programme.

#### Career prospects

Former graduates have gone onto research posts and gained roles in community settings. There are opportunities to pursue professional qualifications such as MPhil and PhD, or to complete the British Psychological Society's Independent Route to Chartered Status.

## Social Work PgDip/MA

#### **Entry requirements**

You will normally have an undergraduate honours degree, postgraduate diploma or degree-equivalent professional qualification. You will also hold a GCSE or equivalent in English language. Exceptionally, you may be admitted if you have an unclassified degree with significant relevant work experience. Prior learning and experience may count for advanced standing. International students please visit mmu.ac.uk/international or see page 30.

#### The course

This programme aims to provide a selective critical introduction to debates in psychoanalytic studies. It is designed to explore and evaluate new contributions as they emerge.

Psychoanalytic studies include close attention to Freud's texts and to main traditions in Anglo-American psychoanalytic practice, specifically object relations and Kleinian, and alternative traditions from France, specifically Lacanian and post-Lacanian. There is also some attention given to group analysis, and group psychotherapy in its Bionian and Foulkesian modes.

The programme is grounded in a critical understanding of subjectivity and there is also focus on problems of ideology and power, and upon the ways in which psychoanalysis mirrors present-day culturally-specific and historically-bound assumptions about human nature, experience and behaviour.

A core module is used to introduce the key issues, prior to developing a programme of study which draws on relevant modules in the MSc scheme. You will also complete a dissertation and be assessed continuously throughout the course.

This course includes the General Social Care Council validated professional qualification for Social Work. The General Social Care Council will close on 31 July 2012 and the Health Care Professions Council will be taking on this role as of 1 August 2012.

#### Career prospects

Successful graduates may wish to approach research posts or gain promotion in their workplace. Depending on the programme studied, there are opportunities to undertake professional qualifications and aim towards higher level learning such as MPhil and PhD.



### Advanced Practice and Leadership in Social Work PgDip/MA

These programmes are for experienced registered social workers and first line social work managers. They provide for the development of knowledge and skills required for Advanced Social Work Practice and Leadership.

Each route on the PGDip features  $3 \times 20$  credits (M Level) mandatory core units and  $3 \times 20$  credits (M Level) units related specifically to your chosen route.



Study is through regular face-to-face tutorials with a supervisory team who will provide you with feedback on the progress of your research.

#### **Career prospects**

The Professional Doctorate could enable you to become a consultant practitioner, a researching practitioner or facilitate employment at a higher managerial level. This Professional Doctorate award applies to the areas of nursing; community health; physiotherapy; speech and language therapy; health; counselling; social care; biomedical science; dental technology and clinically physiology.



## Research in Health, Psychology and Social Care

The Research Institute for Health and Social Change engages in internationally recognised, innovative research in psychological, health and social sciences.

Our research reflects the demands placed on third sector and public services, policymakers and employers and the issues affecting individuals, communities and populations. The key strands of our work are:

- Health and social care professional practice, development and evaluation

- Nutrition and health

The results of our work provide policymakers, professionals, social care providers, housing associations, families and carers, employers, researchers and others with the tools they need to improve health and quality of life within their services and activities. The research connects closely to the interests of different departments, reflecting research into the therapies, nursing, psychology, social work and social change, exercise, sport and rehabilitation science and interdisciplinary studies.

### Quality of Life and Disabling Conditions

A broad spectrum of health and social care academics provide research and consultancy services to inform policy and practice in fields including: learning disability, mental health, long term conditions, communication impairment and addictions. Our research includes, for example, long term follow up of the effects on the family of a member with schizophrenia, and research into different explanatory models of communication impairment held by professionals and family members.

#### **Health and Social Care Practice**

Health and social care practitioners, who are also researchers, offer services in evaluating health and social care interventions. Our research includes, for example, research into the attitudes of older people towards technology in the home, the efficacy of nursing interventions and work with the local adult social and health care services, examining the impact of implementing a new National Service Framework in long term neurological conditions.

### Critical Community Psychology and Disability Studies

An interdisciplinary team of researchers work with disabled people and with people from minority social groups to develop critical research which will result in better life experiences and expose the impact of policy changes on people's lives. Examples of our research includes explorations of experiences of forced labour amongst Chinese workers, evaluations of the experiences of asylum seekers and refugees, inclusive research with disabled people in Malaysia and the UK, and work in both the UK and Pakistan over the policies and practices supporting Pakistani women experiencing domestic violence.

#### Public Health and Wellbeing

Social scientists from different disciplines undertake work on the social aspects of public health. Our work includes evaluating policy initiatives for older people, including citizen researchers, and explorations of the benefits brought to families and communities through the development of intergenerational practice, and participative action research into wellbeing of residents living in areas of urban regeneration. In our research we include work that combines a focus on individuals, families, professionals, communities and policy in different ways. We offer a lively and stimulating environment for PhD study with excellent support and supervision from within our Graduate School.

## Research Profile: Lisa Heaney

#### MSc by Research

I chose to study at Manchester Metropolitan University because of the flexibility and modular nature of the course. My undergraduate degree was in psychology and neuro-science and I wanted to make the next step towards studying for a PhD, so I was specifically looking for a research focused postgraduate course.

The facilities here are fantastic and have allowed me to conduct experiments and undertake practical work. The qualitative methods unit is exceptional.

Being a postgraduate student here is really enjoyable. There are a range of age groups and people from different backgrounds, meaning that I have got to see a lot of different perspectives and widen my experience. The staff are so helpful and I know that I can get the support whenever I need it. I'd definitely recommend studying here.

### Essential information

### Entry requirements

This gives you an overview of the minimum entry requirements for our postgraduate programmes of study. In individual areas of study, however, you may be required to achieve grades higher than the minimum requirements.

It is therefore important to read the individual course entry for the course you wish to apply for which gives details of the typical entry requirements for that course. In particular, courses which lead to an award from a professional body may have specific entry requirements that are set by the professional body.

Satisfying the typical entry requirements may not, however, guarantee the offer of a place. Applications are considered on their own merits and in competition with others, with account being taken of examination results already achieved, predicted grades in forthcoming examinations, research project proposals, personal statements and academic references. In many cases an interview, audition or presentation of a portfolio is also an essential part of the selection process. In some cases, work experience or success in other fields can be accepted as equivalent to formal qualifications.

#### Taught Masters Programmes (MA, MSc)

You should have an honours degree or a postgraduate diploma or a professional qualification recognised as being equivalent to an honours degree. Other qualifications or work experience may be acceptable if they demonstrate appropriate knowledge and skills at honours degree standard.

### Postgraduate Certificate and Diploma (PGCert, PGDip) Programmes

You should have a degree or other qualification at equivalent level. Applicants without a degree, but with appropriate experience may be accepted.

### Master of Research (MRes), Masters degree (MA, MSc) by Research and MPhil

You should have a first or second class honours degree (usually a 2:1) or an equivalent qualification. Applicants will be considered on their merits. Ability and background knowledge in relation to the proposed research, together with professional experience, publications, written reports or other appropriate evidence of accomplishment will be taken into consideration.

Opportunities exist to transfer from Masters by Research to MPhil, and all students registered for MPhil have the opportunity to transfer to PhD after completion of about 9 to 15 months of full-time study (or 15 to 21 months part-time), providing progress on the work demonstrates that development to this level can be achieved.

#### PhD

To apply for a PhD direct, you should have a Masters degree (or equivalent from an overseas institution), in a discipline which is appropriate to the proposed research, and includes sufficient training in research methods and the execution of a research project. If you do not meet these criteria but have had appropriate research or professional experience at postgraduate level which has resulted in published work, written reports or other appropriate evidence of accomplishment, this will be taken into consideration.

#### PhD (by Published Work)

The University offers two routes for PhD by Published Work. These routes provide an alternative for candidates who have acquired substantial experience in a working research environment, as a result of which a number of publications have been produced. Only published work that is available and accessible in the public domain will be eligible for consideration. #### **Professional Doctorate Programme in Health**

Admission to the Professional Doctorate Programme in Health would normally require a good honours degree (or equivalent) and a Masters degree related to your professional discipline (the latter usually completed within a five-year period prior to entry) and at least five years post qualification experience in your professional field.

#### **International students**

If you need to check your eligibility visit our website mmu.ac.uk/ international and check your specific country page for more detailed entry requirements and which international qualifications we accept. We also consider work experience and other factors so do include everything you think relevant in your application.

If you are not a national of a majority English-speaking country you will need to provide evidence of your English proficiency. The level of English we require will depend on the qualification you wish to study and in addition to the entry requirements detailed on the course page, you will also need a minimum of IELTS 6.5 with no less than 5.5 in any section, or acceptable equivalent.



### Funding and financial support

#### **Tuition fees for taught courses**

The fees for taught courses, both full-time and part-time are provided for each course. Fees are correct at the time of going to press but may be subject to change and will be confirmed at the time of enrolment. The part-time fees stated are for the first year and, owing to the flexibility of part-time courses, denote the maximum fee for Year 1. #### Studentships

University Studentships are offered on an annual basis for students wishing to study for PhD, MPhil, MRes or Masters by Research (MA, MSc, LLM) degrees. They are normally held for up to three years and provide the home tuition fees and a subsistence bursary of around £12,000 per annum. Studentships are attached to specific research projects. Industrial CASE awards, which are allocated to the industrial partner i.e. your employer) can become available. **mmu.ac.uk/red**

#### How to apply for a postgraduate taught course

Applications for full-time and part-time taught courses should be made on the Manchester Metropolitan University standard application form available at mmu.ac.uk/applicationform

The University will inform you of the outcome of your application. Some offers may be conditional upon you satisfying the specified entry requirements.

#### How to apply for a postgraduate research degree

You can apply for admission to a postgraduate research degree either by responding to a specific advertisement for a studentship in the local or national press or by applying speculatively to the University.

To apply for a Professional doctorate, PhD, MPhil, MRes or Masters by Research you will need to complete the Application Form to Study for a Postgraduate Research Degree mmu.ac.uk/study/postgraduate. You should also contact the research degrees coordinator for your chosen subject area to arrange a preliminary discussion about your proposed research topic.

If your application is successful you will be required to have an interview. When the University is satisfied that your proposed project is generally sound, your references have been received and that the appropriate supervision and resources are available, you will be sent a letter offering you a place. Enrolment for a research degree normally takes place at the start of each academic term, i.e. September, January and April, although some programmes may only have one enrolment period per academic session.

Following enrolment, in order to register for the degree you will be required to produce a research proposal of 1,000 words, with the help of your proposed supervisory team, and submit it to your Faculty Research Degrees Committee for approval within three months (full-time) or six months (part-time) of enrolment.



### International Students

#### **Entry requirements**

As a guide for most postgraduate courses you will need to achieve IELTS 6.5 or above with no less than 5.5 in any component. There are pre-sessional English courses during July and August to help you achieve the level of English language proficiency you need before you start your course.

#### **Applying**

Once you've decided which course to apply for, you will need to submit your application. Many international and EU students use a recruitment consultant or education advisor based in their home country to help them. The University works with a number of Education Advisors worldwide and you may find that we have one in your country. They will be able to tell you more about the University and how to present yourself in a way that will interest admissions tutors and some will offer you assistance with your visa and pre-departure briefings. 







