

Cancellation and Refund Policy – 2023 – 2024

Policy Notes


All cancellation requests should be sent in writing to <u>accommodation@mmu.ac.uk</u> stating your full name, ID number and the reason why you would like to cancel and the applicable evidence to support your cancellation.

If you cancellation is due to mitigation circumstances then this can be reviewed by management on a case-by-case basis, who may decide to terminate your contract.

Applicable evidence will need to be written confirmation of your withdrawal and / or mitigating circumstances

The 4 weeks' notice charge if you have moved will commence from when you have given up possession on your room (checked out of the accommodation) if you have not moved in, this will commence from when written confirmation and / or the formal request has been submitted.
